10:40-10:50 National Updates

When we last met December 2022, we talked about the AT Act waiting to be reauthorized by the federal government. It had not been reauthorized since 2004. It was reauthorized. Our core services are unchanged mostly. Small periphery changes. There are some new, mandated additional AT Council memberships, this information will come in summer. Council members are needed from Developmental Disability Division or Adult Services Division. Also required is collaboration with other organizations which we already have relationships with. Minor adjustments to funding formulas. The Senate Committee on Health and Human Services authored the new re-authorization. Large portions of the work were done by a legislative staffer from Sen. Patty Murray's (WA) team but this staffer will be staying with HHS and has become a member of Bernard Sander's staff.

We belong to Association of Assistive Technology Act Programs, (ATAP). The annual leadership symposium, this year will be virtual. ATP (Phil) and MFP(Lynne) will do an MFP presentation for all states. We also submitted a One Big Thing video. We featured an OT program setting up a Smart Apartment. Once uploaded to You Tube, we will share.

Recent, prolonged, staffing challenges for AT Program have come to an end. This allows us to meet the demand for services with a full staff.

Phil and Joy did an <u>hour long WDEV radio interview</u>. It has been nice to get out and talk about our program publicly again.
